

# **Exhibitor Display Information**

- Space ISN'T AUTOMATICALLY held for past exhibitors. Past exhibitors AREN'T AUTOMATICALLY placed in the same location as previous year. Applications received from past exhibitors by August 1, 2017 will be processed before accepting applications from new exhibitors.
- If your display **NEEDS TO BE NEXT TO** another exhibitor for business purposes be sure to indicate that information on your application.
- Your display **MUST NOT BLOCK THE VIEW** of a display on either side of your exhibit. Refer to drawings on Exhibitor's Guidelines under Exhibit Dimensions Section. The trade show committee **WILL STRICTLY ENFORCE RULES** pertaining to placement of equipment so it will not block the view of another display.
- All booths will be located in the exhibit hall. All booths are 10' wide x 10' deep. Again, this year we are offering exhibitors who are also auction donors a chance to be located in the prime area booths circling PORK CENTRAL. These prime spaces are limited. We may not be able to locate all auction donors in this area; therefore, **space will be assigned on a first-come, first-served basis.**
- The Association will do their best with location preference, but cannot guarantee space. Please understand, if more than one company requests the same area, several factors will be considered:
  - 1. Participation in the Pork Production Auction at 2018 Expo.
  - 2. Date application is received with proper deposit or full payment.
  - 3. Number of spaces requested.
  - 4. Past experience as show exhibitor.
  - 5. Participation in other IPPA programs throughout the year.
- Exhibitors will need to **remain** setup until the show ends at 3:00 p.m., Wednesday, Feb. 7.
- IPPA will raffle one booth space (\$500 value) for the 2019 Illinois Pork Expo at 3:00 p.m. on Wednesday, Feb 7, 2018. **Must be present to win.**
- Exhibitors must have booth **set up by 10:00 am on Tuesday, Feb. 6.** You will then be required to exit exhibit hall so decorators can lay the carpet and set up for the Legislative Reception. Exhibitors will then be able to enter at 3:00 p.m. for the start of the trade show.

## IPPA Pork Production Auction • February 6, 2018

## What is it?

The auction is an opportunity to showcase your company's products and services to Illinois pork producers, while supporting the pork industry. Each year IPPA holds the Pork Production Auction to raise non-checkoff revenue for programming areas in Illinois such as legislative activities, lobbying, communications, etc. In 2017, IPPA raised over \$38,900 at the event attended by key pork producers, legislators and allied industry reps.

## How Does It Work?

Companies donate pork production related items such as: feed, equipment and pharmaceuticals (items/services producers would utilize in their operation). Companies are urged to donate gift certificates applicable for a wide range of products and services. Donations are also encouraged for non-production items such as gift baskets, trips and other unique items to increase the numbers of bidders.

Donations may be more than one item (\$250 minimum value for each item). <u>The total donation</u> <u>must be valued at \$750 or more to be included as an auction donor.</u> A list of items donated at last year's auction is enclosed for your reference. Items will be sold by an auctioneer on Tuesday, February 6 starting at 7 pm in the "Pork Central" area on the tradeshow floor. Certificates for the items are given to the buyer and the producer plans with the company for delivery of the items.

## What do auction donors receive in return?

Companies donating \$750 or more worth of products and services will receive:

- Prime Exhibit Space at the 2018 IL Pork Expo Auction donors will have first chance of booth locations surrounding the "Pork Central" area of the trade show, where the auction will be held, as well as, the Legislative Reception. This area will also include refreshments and a place for attendees to relax and visit. This location will result in higher visibility for your company with more contacts to producers.
- <u>Recognition at the Expo</u> Auction donors will have a sign to display at their booth indicating they are an auction donor and will be recognized during the auction and throughout the Expo. A color power point slide featuring your company logo and/or your donated item will also be displayed in Pork Central during the trade show on Tuesday.
- 3. <u>Advertisement to Producers</u> Auction donors will be included in the list of auction items mailed to IPPA members and highlighted on IPPA's website.



#### **Booth Assignments**

Allocation of booths is made on the basis of number of spaces requested, date application is received by Association (with proper payment), participation in Pork Production Auction, previous participation, and the diversification of similar exhibits. If paying by credit card, reservations for space will be accepted by fax. The Association reserves the right to refuse an exhibitor based upon a perceived conflict of interest.

It is agreed, that if for any cause which arises beyond the control of the Association, it becomes necessary to move an exhibitor to a different location, space allocation will be made at the discretion of the Association. The exhibitor will be notified immediately.

#### **Rate, Payment and Cancellation**

Make checks payable to Illinois Pork Expo.

Refer to Application/Contract for Exhibit Space for current booth rental rates and payment terms.

If it becomes necessary to cancel your request for exhibit space, your notification must be submitted to the association in **writing**. **Telephone cancellations won't be accepted**. \$100 per booth is non-refundable after application has been accepted by the Association. Written cancellation notice received at the Association by October 3, 2017 will qualify for refund of all but \$100 per booth. After October 3, 2017, no refund will be available unless the show is a sell out.

#### Registration

Each Exhibitor is provided four free pre-registrations for each booth space rented. All attendees must be registered and wear the official Illinois Pork Expo name badge for admission to exhibition. These badges are not transferable and must be worn at all times.

All Exhibitors shall pre-register their personnel by January 19, 2018. Any additions or changes in pre-registration must be certified by an officer of the exhibiting firm or by the person in charge of the company's booth space by January 19, 2018.

Any models, demonstrators or equivalent personnel participating in an Exhibitor's booth must be registered and will count as one of the allotted registrants in that booth.

#### **Exhibit Area**

Admittance to technical exhibits is limited to individuals, business firms, manufacturers, and dealers who have contracted and paid for space assignments. No other persons or concerns will be permitted access to the exhibit hall for the purpose of demonstrating their products, distributing advertising materials, or for any other purpose. Any violation of this rule will be followed by prompt ejection of the offending person(s) from the exhibit hall.

Visitors should be contacted and all matters conducted within the confines of the Exhibitor's own booth.

Models or similar personnel employed by the Exhibitor will be admitted to the exhibit floor in costumes approved by the Association.

Representatives are defined as individuals who receive commission, brokerage, or salary from the exhibiting firm, and must be so certified. Excluded from this category are representatives who maintain and own inventories of merchandise for resale. Such people are considered to be dealers and must purchase exhibit space in order to be admitted to the exhibit floor.

#### **Fire Laws**

Flammable materials must be flameproofed before being taken into the exhibit building to the extent that such materials will meet the test of inspection authorities of the local Fire Prevention Division.

#### **Booth Supplies**

Labor, equipment and /or supplies needed for the setup, operation or dismantling of exhibits is to be ordered from the official decorator. Shipping of exhibit supplies must be made to the decorator. No material will be accepted by the Bank of Springfield Center.

The decorator will contact each Exhibitor approximately 30 days prior to show date requesting specific information regarding Exhibitor's special requirements and giving shipping and labor cost details.


#### **Exhibit Dimensions**

Exhibit booths are 10' wide by 10' deep. Booth backgrounds are 8 feet high and divider rails are 3 feet high. The display in the booth cannot block the view of the exhibit on either side. It is recommended that the front one-third (3 feet) of the display not exceed the 3 foot side rails.

The Association reserves the right to approve/disapprove display, especially multi-booth displays which could block visibility of other exhibits. The Association will insist on having each Exhibitor use good taste. Plans for specially built displays not in accordance with guidelines should be submitted to the Association for approval before construction is ordered.

#### **Eligible Exhibits**

The Association reserves the right to determine the eligibility of any company or product for inclusion in the Illinois Pork Expo.

#### **Animals Prohibited**

No live animal(s) will be permitted in, or as a part of, any exhibit.

#### **Rejected Displays**

The Exhibitor agrees that his/her exhibit shall be admitted and shall remain from day to day solely on strict compliance with the guidelines herein set forth. The Association reserves the right to reject, eject, or prohibit any exhibit in whole or in part, of any Exhibitor or his/her representatives, with or without giving cause. If cause is not given, liability shall not exceed the return to the Exhibitor of the amount of rental unearned at the time of ejection. If any exhibit or exhibitor is ejected for violation of these guidelines, or for any other stated reason, no return of rental shall be made.

#### **Special Visual and Sound Effects**

Audio-visual equipment and other sound and attention-getting devices and effects will be permitted only in those locations and in such intensity as, in the opinion of the Illinois Pork Expo chairman, do not interfere with the activities of the neighboring Exhibitors.

Films purely for entertainment, without educational or informative value, will not be permitted.

#### Music

Exhibitor's display cannot include music of any type.

#### **Defacing of Building**

Exhibitors are liable for any damages caused by fastening displays or fixtures to the building floors or walls or to the standard booth equipment, or for damages caused in any other manner. Exhibitors may not apply paint. lacquer, adhesive or any other coating to building walls and floors or to standard booth equipment.

#### **Special Restrictions**

a. Exhibitors must confine their activities to the space for which they contracted.

b. Distribution of samples, literature, or souvenirs is permitted only from the exhibit booth. No food or beverage packaged so it can be consumed in the exhibit hall will be approved.

c. Exhibitors who use costumed personnel or mannequins must be sure that their manner of appearance and dress is such as not to offend the most critical. All such personnel must confine their activities to the space contracted for.

d. Exhibits which, in design or operation, are objectionable in the opinion of the Association will be prohibited.

e. Although meetings of the Association are conducted primarily for educational purposes, it is recognized that an appropriate social program may contribute to the pleasure of those attending. Social functions shall be scheduled at a time or place where they will not conflict with activities scheduled by the Association or with the exhibition. Written notice of such activities that could involve the Illinois Pork Expo attendees should be sent to the Association by October 3, 2017.

#### **Exhibitor Housing**

Exhibitors will receive housing information prior to general opening of convention housing. An appropriate percentage of hotel room space will be allotted to Exhibitors and will be offered on a first-come first-serve basis.

#### Cancellation

In the event of cancellation of exhibit due to fire, strikes, government regulations, or other causes beyond the Association's control, the Association shall not be held liable for failure to hold the Illinois Pork Expo as scheduled, and the Association shall determine the amount of exhibit fees to be refunded, if any.

#### Admission

The Association shall have sole control over all admission policies at all times. All persons visiting the exhibits or attending any function of the convention will be required to register and to wear the official Illinois Pork Expo badge while in attendance.

#### Amendments

The Association shall have sole authority to interpret and enforce all guidelines contained herein; to make any amendments thereto, and make such further guidelines as shall be necessary for the orderly conduct of the exposition.

#### Penalties

Any Exhibitor violating the guidelines as published herein and subsequent information will forfeit the right to exhibit in subsequent years.

#### **Exhibitor's Representative**

The Exhibitor will name one individual as duly authorized representative to have charge of the exhibit, and hereby accepts and assumes responsibility for such representative or alternates being in attendance at the exhibit throughout all exhibit periods.

This individual will receive all official correspondence and will be responsible for communicating this information to registered personnel from the exhibiting company. Such representative shall be authorized to enter into such service contracts as may be necessary and for which the Exhibitor shall be responsible.

#### Installation/Dismantling

Installation of exhibits may begin on Monday, February 5 at 2:00 p.m. and must be completed no later than 5:00 p.m. the same day. And on Tuesday, February 6 from 7:00 a.m. and must be completed no later than 10:00 a.m. the same day. Those Exhibitors having large or unusually complicated exhibits should contact the Association for special arrangements.

No exhibit may be dismantled prior to official closing of exhibits on Wednesday, February 7, at 3:00 p.m. All exhibits must be removed in total by 7:00 p.m. on Wednesday, February 7.

#### Failure to Occupy Space

All space not occupied by 10:00 a.m., Tuesday, February 6, will be forfeited by the Exhibitor and the space may be resold, reassigned, or used by show management without refund.

#### Subleasing

Exhibitors may not sublet their space or any part thereof.

#### **Non-Association Services**

Approximately 30 days prior to show the Exhibitor will be furnished with full details of shipment to and from the decorator, rental equipment, electrical, air, gas, and water service information sheets, along with special services and additional decoration advance order forms. Full instructions for shipping and charges for labor will be included in the packet mailed by the decorator.

#### Strikes

The Association and the exposition management will not be responsible for delays, damages, loss, increased costs, or other unfavorable conditions caused by strikes, government order, emergency, or other circumstances beyond their control.

#### Limitation of Liability

The Exhibitor assumes full responsibility for property damage, personal injury or death to any party by reason of the Exhibitor's participation in the exhibition or convention activities, and the Exhibitor agrees to defend, indemnify and hold the Association, its subcontractors and the convention center harmless from all liability which might ensue from any act of God or any cause whatsoever arising out of the Exhibitor's participation in the exhibition or in convention activities.

The Association, its employees, subcontractors and the convention center will not be liable for injuries to any person or for damages to property owned or controlled by the Exhibitor, which claims for damages or injuries may be incident to, arising from, or in any way connected with the Exhibitor's occupation of display space; and the Exhibitor agrees to defend, indemnify and hold the Association, its employees, its subcontractors, and the convention center harmless against all such claims.

The Exhibitor expressly understands and agrees that the forgoing liability clauses apply not only during the exhibit hours, but also at all other hours of each day for the period extended from the commencement of installation until the final removal of the Exhibitor's property and personnel from the convention center, and to any latent or contingent damage, injuries or liability arising or discovered at a later date as the result of, or arising out of, the Exhibitor's participation in the exhibition.

The Association, its employees, subcontractors or the convention center will not be responsible to any degree whatsoever for any ill effects caused any person or group of persons in attendance prior to, during and after the close of the 2018 Illinois Pork Expo for any samples taken or by any other means given them by the Exhibitor representatives.

#### Insurance

#### Liability Insurance

Each Exhibitor should extend coverage for public liability insurance for the duration of the Illinois Pork Expo to protect against possible claims arising out of the set-up, operation, and dismantling of its booth. Also refer to "Limitation of Liability."

#### Theft and Fire Insurance

Theft and fire insurance floater policies are highly recommended. Small or easily portable articles of value should be properly secured or removed after exhibit hours and placed in safe keeping. The Illinois Pork Expo policies DON'T include fire and theft coverage for individual exhibit booths.

#### Security

Each Exhibitor must make provision for the safeguarding of his goods, materials, equipment, and display at all times and wherever the same may be located within, on or about the exhibition hall premises. General overall watchmen will be employed by the Association for the convention period, but neither the Association, its subcontractors, or the convention center will be responsible for property damage, or loss by or for any cause, and Exhibitor hereby waives any right to claim liability against them for the same.

#### Purpose of Exposition

The Exposition is for educational and informational purposes. Regulations prohibit the direct sale by an Exhibitor of any material in the exhibit area.

#### Show Costs

Exhibitor fees cover space rental for the period of the market, use of display equipment (8' high back drape, 3' high side drape and 1-line identification sign). Labor for installation and removal of all exhibit material will be at the Exhibitor's expense. Local regulations and charges for additional exhibit accessories such as telephones, electrical outlets, spotlights, or other items not furnished by the Association, will be listed in the information packet furnished by the decorator.

#### Complaints

All complaints on the part of Exhibitors, and all requests for Trade Show information and assistance, should be directed to the Illinois Pork Expo Chairman, rather than to the management of the Bank of Springfield Center.
