We, the undersigned, hereinafter referred to as Exhibitor, hereby submit our application to participate as an exhibitor at the 2023 Illinois Pork Expo, hereinafter referred to as Association, subject to all terms and conditions set forth in the Exhibitor's Guidelines (copy enclosed). Further, we agree to and understand that applications not accompanied by full payment OR earnest deposit will not be considered. Final payment of any unpaid balance will be required by DECEMBER 1, 2022. In the event an exhibitor fails to remit full payment by December 1, 2022, this application will be considered void.

With this agreement between the Association and the Exhibitor, and in consideration of payment schedule as outlined on page one of this contract, the Association hereby leases the designated booth space(s) in the exhibit area of its 2022 Illinois Pork Expo for the duration of the exposition. The Association agrees to carry through the arrangements and program therewith; to conduct a Trade Show in connection therewith; substantially in accordance with the letter of invitation to prospective Exhibitors; and to rent to the Exhibitor the booth space(s) shown on the contract as selected by the Association. The Association reserves the right to limit the number of exhibit spaces an exhibitor may have. The Association reserves the right to refuse an exhibitor based upon a perceived conflict of interest.

If it becomes necessary to cancel your request for exhibit space, your notification must be submitted to the Association in writing. \$100 per booth is non-refundable after application has been accepted by the Association. Written cancellation notice received at the Association by December 1, 2022 will qualify for a refund of \$100 per booth. After December 1, 2022, no refund will be available unless the show is a sell out.

It is agreed, that if for any cause which arises beyond the control of the Association, it becomes necessary to move an Exhibitor to a different location, space allocation will be made at the discretion of the Association.

This contract is subject to, and the Exhibitor agrees to observe, all points of information and regulations as set forth in the Illinois Pork Expo "Exhibitor Guidelines" and subsequent information. Violators will lose their right to exhibit at the Illinois Pork Expo in subsequent years.

The contact person named on the reverse is designated as the authorized representative to have charge of the Exhibitor's space. This individual will receive all official correspondence relating to the exhibit space.
